EDC Membership Terms and Conditions

1. Members must be of legal age in the province or state in which they reside.
2. Upon approval and acceptance of this application by EDC Wellness Corp the Member will be an Independent contractors responsible for his/her own business and not an employee of EDC Wellness Corp.
3. EDC Independent Members must abide by any and all federal, provincial and local laws, rules and regulations pertaining to this agreement and/or the acquisition, receipt, holding, selling, distribution or advertising of the company's products. The Member will also be solely responsible for the declaration and payment of local, provincial and Federal taxes as may accrue because of the Members' activities in connection with this agreement.
4. EDC's primary emphasis is on the wholesale and retail sale of company products.
5. A Member may not stockpile products in order to generate commission checks. 70% must be sold before re-ordering.
6. An EDC Member shall have the right to sell products in accordance with the company's compensation plan.
7. Members may not make any statements or representations regarding the company's products or compensation plan other than those contained in materials provided by the company. Failure to comply with this provision may result in the suspension or termination of the Member.
8. EDC Members agree to familiarize him/herself with EDC's products, product descriptions, terms, conditions, policies, procedures, and website and compensation plan.
9. The company and the Member understand and agree that the company may, from time to time in its sole option, modify the compensation plan, these terms, conditions, policies and procedures which, upon their provisions to the Member in writing, shall become an integral part of this agreement.
10. In the event a dispute shall arise between the company and the Member to the respective rights, duties and obligations under this agreement, such disputes shall be exclusively resolved pursuant to binding arbitration under the commercial rules of Canadian Arbitration with arbitration to be held at Vancouver, British Columbia. The arbitrator shall award, in addition to declaratory relief, injunctive relief, and compensatory damages, reasonable attorney fees and costs to the prevailing party. The decision of arbitrator shall be final and shall be entitled to enforcement in any court of competent jurisdiction. This provision shall not prohibit EDC from seeking injunctive relief in any court of competent jurisdiction.
11. The Member will be allowed to cancel or sell their position at any time for any reason upon written notice to the company.
12. A distributorship must be offered to three people upline starting with your sponsor before it can be sold. The approval for the sale must be given by the company.
13. The Members will do no advertising in any way without the prior approval of the company.
14. The company reserves the right to terminate any Member for not complying with these terms, conditions and policies.
15. The Member understands that his/her Member position can be inherited or bequeathed, but cannot be transferred or assigned during his/ her lifetime without written consent of the company which consent shall not be unreasonably withheld.
16. The Member acknowledges and understands that this agreement shall not be binding on either party until it has been accepted by the company at its corporate office and shall be governed by the laws of the Province of British Columbia.
17. All commissions are paid in Canadian currency.
18. Checks will be issued when rebates, commissions and/or bonuses accumulate to \$30. Or more.
19. There will be an administration charge on each check of \$3.00
20. All qualifying BINARY TEAM income and Fast Start bonuses will be calculated at 5pm on Friday and paid the following Friday.
21. There will be a renewal fee after one year of \$50 for membership, website and back office hosting.
22. The Revenue Sharing bonus will be paid yearly and will start the 1st of the month when all eligible Executive and Founder positions are filled. This is calculated on total company PV volume.
23. At this writing of January 2006, Personal Marketing Packs, rebates and profit sharing are only available to Canada and US distributors.
24. An initial minimum order of 100PV and subsequently 50PV monthly must be maintained to remain active to receive commissions, rebate checks, fast start or Matching Bonus. If a distributor is inactive, the volume will not accumulate to their Business Center the following month. However, if they purchase a minimum of 50 PV the next month, the volume will start accumulating again in the next calendar month.
25. All Executives and Founders must have a minimum monthly 50PV autoship in order to qualify in the Revenue Sharing Pools. In the event that autoship requirements for the month have not been met EDC requires that an order be placed and received at head office no later than midnight (Pacific Standard Time) in order to qualify.
